

Frequently Asked Questions

- Q 1. I have read your Maharishi Vidya Mandir Schools Associate/Franchisee Programme advertisement. Noticed the same on your site. What is this all about?
- Ans.1- Our Maharishi Vidya Mandir Schools Associate programme or franchisee branches offer is open for all newly planned schools. The individuals, Trusts and Societies who wish to go for an alliance with Maharishi Vidya Mandir Schools in order to capitalize with the expertise and experience of Maharishi Schools can contact us.
- Q2- What is the requirement of the land and building construction?
- Ans.2- If one plans CBSE School, then one needs minimum one acres of land and suitable building as per CBSE norms. In case of state board affiliated school, the requirement of land and building differs as per respective state board norms.
- Q3- What is the expected cost of construction
- Ans3- Construction cost varies from place to place in India, but for a small school to start with, it will cost about Rs. 50/- lakh minimum. Once School is running more rooms can be added as per requirement later.
- Q4- What is the procedure of applying for Associate/ Franchisee programme?
- Ans4- As that you have visited our site; you are suggested to download the Application Form from the section of Associate/Franchisee programme and forward duly filled up form along with all relevant documents and photographs to following address for evaluations. In case of any difficulty in downloading, please contact the phone numbers of our Bhopal and Delhi office mentioned on the site as per the suitability of your place of operation you may contact either office.  - 5- BUILDING MAP, SITE PLAN, BUILDING PHOTO FROM ALL FOUR SIDE
 - 6- LAND MAP
 - 7- 3YEARS AUDITED BALANCE SHEET
 - 8- LEASE AGREEMENT [in case school is running in rented building does not have own Land]
 - 9- LAND REGISTRATION
 - 10- LIST OF STAFF, WITH QUALIFICATION AND POST, DETAILS OF SALARY PAID
 - 11- PROSPECTUS OF SCHOOL
- Q6- What are the process adopted after application submission.
- Ans.6- As soon as application is evaluated an inspection committee visits your school site for further evaluating the feasibility of the proposal. After receiving inspection report, if any shortcomings are reported the same is discussed and suggested for improvements.

Q7- Guide line for Building plan, Map, etc.

Ans.7- In case you already have Land and building ready, please make sure site plan and building plan is enclosed with the application. After seeing the plan and site suggestions if needed are communicated for improvement. Under the circumstances of only land availability, construction guidance is provided by our experts as per government and Vastu norms of Maharishi Vidya Mandir Schools.

Q8- Teaching/non teaching staff shall be recruited by applicant or MVM?

Ans.8- You may initiate appointment of the staff. However if you need any guidance on above, shall be provided. Its better if Maharishi Vidya Mandir experts are included in recruitment process.

Q9- Who Shall pay the salaries to the school staff?

Ans.9- Arrangement of funds to start and manage the school shall be the responsibility of applicant school which includes salary of teaching/non teaching. In addition to regular teaching and non teaching staff MVM will provide a TM teacher salary of TM teacher will be paid by the applicant school.

Q10- What are the benefits getting associated with Maharishi Vidya Mandir Schools Group?
